The Fund is managed by Gemini Capital Management (Ireland) Limited which acts as manager to the Company

## Objectives and Investment Policy

The Fund aims to maximise growth and income by generating long-term total returns.

The Fund is actively managed against the Solactive GBS Developed Markets Large and Mid Cap USD Index NTR.

The Fund aims to achieve this by investing more than 50% (which at times could be up to 100%) of its assets in shares of large, medium and small companies located and listed on exchanges in countries with developed economies. The Fund may also invest up to 20% of its assets in emerging markets (countries that are still developing their economies).

The Fund may achieve exposure to shares of companies in developed markets by investing up to 20% of its assets in other funds and up to 10% in other similar instruments (including exchange traded funds).

The Investment Manager will also bias the portfolio towards companies that are assessed to have higher scores with respect to environmental, social and governance (ESG) criteria in determining the weight of that company in the portfolio. The ESG criteria cover companies' exposure to and management of the following: Environmental issues: such as climate change and carbon emissions, air and water pollution, and energy efficiency; Social issues: such as

gender and diversity, human rights, and labour standards;

Governance issues: such as board composition, executive compensation, and audit committee structure.

The Fund may invest its assets in derivatives as set out in the Fund's Supplement or it may use them in order to manage the Fund more efficiently (e.g. reducing risks or costs or generating additional growth or income).

The Fund will not distribute any dividends in this share class. Income and gains of this share class will be accumulated and reinvested on behalf of shareholders.

You may buy and sell your shares on any day on which banks in Ireland and the United Kingdom and the New York Stock Exchange are open for normal business.

Recommendation: This Fund may not be appropriate for short-term investment.

The Fund may use techniques (investment level hedging) to try to limit currency exchange risk, but there is no guarantee these will be successful.

The indicator opposite does not take account of the following risks of investing in the Fund:

**Class Currency risk:** your shares are priced in Euros whereas the Fund's base currency is U.S. Dollars. The Fund does not use techniques (share class level hedging) to try to limit the class currency exchange risk and changes in exchange rates may lead to fluctuations in the value of your investment.

**Derivative Risk:** the value of a derivative depends primarily on the performance of the underlying asset. A small movement in the value of the underlying asset may cause a large movement in the value of the derivative which may result in a loss to the Fund. The Fund is exposed to the risk that the other party to the derivative will not meet its obligations.

**Small and medium sized company risk:** Smaller and medium sized companies tend to have younger and more limited product lines, markets and finance and a smaller management team. As a result they may be more difficult or impossible to sell which could adversely affect your investment.


